#### **Resolution on the Right to Keep and Bear Arms**

WHEREAS the individual right to keep and bear arms is fundamental to the fabric and preservation of a free republic; and,

WHEREAS our nation is currently experiencing renewed efforts to infringe on this right, efforts that would undermine each individual's ability to freely defend his life, liberty, and property; and

WHEREAS if successful, these efforts would further threaten the safety and security of all Texans, including children and those most vulnerable to attacks; and,

WHEREAS Texas Republicans know that the principled and effective response to those with violent intent is to acknowledge that evil will always exist and that the best preservation of our safety as individuals and as a free republic is our citizens bearing arms without government regulation; now

THEREFORE, BE IT RESOLVED that the Republican Party of Texas calls upon all Americans to embrace personal responsibility through the exercise of their inalienable right to defend themselves and their property; and

BE IT FURTHER RESOLVED that the Republican Party of Texas renews our call for passage of constitutional carry legislation that removes restrictions on the freedom of law-abiding citizens who possess firearms to carry those firearms and also our call for the elimination of government-mandated zones in which citizens are disarmed; and,

BE IT FURTHER RESOLVED that we call on all of our elected officials, including state legislators and congressmen, to seek solutions that result in increased safety without sacrificing freedom, to work against all measures that would infringe on the ability of law-abiding citizens to keep and bear arms, and to work to restore the ability of citizens, including willing teachers, coaches, and school staff, to exercise their rights to own and carry personal arms without government interference or regulation; and,

BE IT FURTHER RESOLVED that this resolution be distributed to all Republican members of the Texas House of Representatives and Senate, the Governor, all Republican members of the United States House of Representatives and Senate representing Texas, and the President and Vice President of the United States; and,

BE IT FINALLY RESOLVED that the Republican Party of Texas, on behalf of the grassroots, craft a press release in support of this resolution and make reasonable efforts to promote its distribution to the press and the public.

#### **Resolution Supporting the Electoral College**

WHEREAS the Electoral College represents the considerable genius of our Founding Fathers in the United States Constitution; and

WHEREAS the framers of the Constitution wisely created a balanced representative democracy retaining majority rule with protections as established by the Electoral College from tyranny of the majority; and

WHEREAS the Electoral College was designed to ensure the fair distribution of representation in selecting a President without the predominance of one region; and

WHEREAS the Electoral College provides an efficient and peaceful transfer of power by protecting the minority and regional interests; and

WHEREAS the so-called National Popular Vote Interstate Compact (NPVIC) is a threat to our Constitutional Republic, since the NPVIC allows the popular vote in as few as two heavily populated communities determine a Presidential Election; and

WHEREAS the NPVIC allows a short cut to circumvent the Constitutional requirement of 38 states to amend the Constitution; and

WHEREAS the NPVIC creates a majority by forcing electors to vote against the votes cast by the constituents of their own state; and

WHEREAS the elimination of the Electoral College would encourage presidential candidates to champion the causes of a very small geographic area, effectively ignoring most of the states; and

WHEREAS the elimination of the Electoral College could amplify the effects of vote fraud by a very small geographic area; and

WHEREAS the Electoral College provides for a broad representation of the whole United States; now

THEREFORE, BE IT RESOLVED that the Republican Party of Texas supports the Electoral College and opposes the National Popular Vote Interstate Compact and urges the Texas Legislature to defend the Electoral College as created in the U.S. Constitution.

### Vote 004: RPT Rule 8A amendment

#### Rule No. 8A – Petition Required for County Chairs in Certain Counties

Persons filing for the office of County Chair in a county with a population of 300,000 or greater in a county with a minimum of eight (8) incumbent precinct chairmen shall include a nominating petition containing the signatures of at least 10 percent of the incumbent precinct chairs serving on the County Executive Committee, or two (2) -- whichever is greater, using a form of promulgated by the Republican Party of Texas. The nominating petition shall contain the candidate's sworn oath that each of the signatures thereon is of an current incumbent Precinct Chair and was signed in the presence of the candidate.
