A quorum having been determined, Chairman Rinaldi called the meeting to order at 5:26 p.m.

Without objection, the SREC elected to forego the reading of the Minutes from the Fourth Quarter SREC Meeting held December 10, 2022, and the Minutes stood approved as submitted.

Next, the SREC heard the report from Treasurer Fred Tate.

Without objection, the SREC entered into executive session at 5:36 p.m. The SREC proceeded in executive session until 6:09 p.m.

When the open meeting resumed, the SREC heard the report from National Committeeman Dr. Robin Armstrong, read in his absence by Gaylyn DeVine, SD 11. Chairman Rinaldi then gave his report.

The SREC then heard reports from standing committees. Robyn Cooper, SD 29, gave the report of the Party Organization Committee. Chairman Rinaldi gave the report of the Officials Committee.

Pursuant to SREC Bylaws, Article VII, Section 8(c)(12), Chairman Rinaldi appointed the following to the Candidate Resource Committee (CRC):

The appointments were approved without objection. The reappointed CRC Chair Susan Wright gave the Committee report.

Steve Evans, SD 28, with a second, moved the adoption of the "modified Jean McIver" rule to govern debate on any debatable question for the remainder of the First Quarter 2023 SREC meeting: five speakers in favor, five speakers opposed, and two minutes each for main motions, and three speakers in favor, three opposed, and two minutes each for amendments and other debatable motions. Fernando Garcia, SD 19, moved with a second to amend the motion to permit five speakers on each side of a question and three minutes each for main motions. The amendment failed. The main motion passed.

From 6:49 p.m. CST, without objection, the SREC stood at ease until 9 a.m. the following day.

Gaylyn DeVine, SD 11, gave the report of the Proxy Committee: at the time of the roll call, four proxies were in effect.

The SREC heard reports from National Committeewoman Toni Anne Dashiell and Vice Chairman Dr. Dana Myers.

Chairman Rinaldi offered his gratitude to RPT Finance Chairman Senator Mayes Middleton (SD 11) for sponsoring the meeting.

The SREC then heard reports from standing committees.

Jerry Fisher, SD 2, gave the report of the Partnerships and Coalitions Committee. As part of Ms. Fisher's report, Michael Salvo, Political Director for the Texas Young Republicans, addressed the SREC.

Without objection, former SREC Rep. Mark Dorazio (HD 122) addressed the SREC.

Scott Bowen, SD 6, gave the report of the Resolutions Committee.

By direction of the Committee, Mr. Bowen moved the adoption of the "Resolution Supporting Educational Freedom." The resolution passed by electronic roll call vote of 63 Yes, 0 No.

By direction of the Committee, Mr. Bowen moved the adoption of the "Resolution to Oppose Ranked Choice (Preferential) Voting." The resolution passed by electronic roll call vote of 63 Yes, 0 No.

By direction of the Committee, Mr. Bowen moved the adoption of the "Republican Party of Texas Resolution on Fossil Fuels." The resolution passed by electronic roll call vote of 62 Yes, 0 No, 1 Abstain.

By direction of the Committee, Mr. Bowen moved the adoption of the "Resolution Asking School Boards to Disassociate from TASB." Jim Pikl, SD 8, moved with a second to move specific references to bills from the *Resolved* clause to a *Whereas* clause, and the amendment

passed. The resolution, as amended, passed by electronic roll call vote of 62 Yes, 0 No, 1 Abstain.

By direction of the Committee, Mr. Bowen moved the adoption of the "Resolution to Terminate Membership in the Electronic Registration Information Center (ERIC)." With a second, Chris Byrd, SD 25, moved the following amendment:

- 1. Strike the second *Whereas* clause and insert the following, "WHEREAS, ERIC receives Personally Identifiable Information of citizens and minors regardless of voting status from those states' departments of motor vehicles; and"
- 2. Strike the eighth *Whereas* clause and insert the following, "WHEREAS, during the 2019 session, the 86th Texas Legislature appropriated \$1.5 million taxpayer dollars, most of which is used to contact potential voters for Texas to join ERIC; and"
- 3. Strike the first *Resolved* clause and insert the following, "THEREFORE, BE IT RESOLVED that the Republican Party of Texas calls for the Texas Legislators to pass legislation that would allow for the prompt removal of Texas from the ERIC program and implement an auditable service reconcilable to Texas counties; and"
- 4. Strike the final *Resolved* clause and insert the following, "BE IT FURTHER RESOLVED, the Republican Party of Texas supports the stated intent and both legal and legislative efforts, including, but not limited to, SB 399 submitted by Sen. Bob Hall, SB 1070 submitted by Senator Bryan Hughes, and HB 2809 by Representative Jacey Jetton to remove Texas from the ERIC program."

The amendment passed. Jim Pikl, SD 8, moved with a second to move specific references to bills from the *Resolved* clause to a *Whereas* clause, and the amendment passed. The resolution, as amended, passed by electronic roll call vote of 62 Yes, 0 No. 1 Abstain.

By direction of the Committee, Mr. Bowen moved the adoption of the "Resolution Opposing Casino Gambling in Texas." The resolution passed by electronic roll call vote of 55 Yes, 5 No, 3 Abstain.

By direction of the Committee, Mr. Bowen moved the adoption of the "Resolution Calling on City Council Candidates to Support Ending Taxpayer-Funded Lobbying." Jim Pikl, SD 8, moved with a second to strike "who identify themselves as Republicans" from the *Resolved* clause. Without objection, Tom Nobis, SD 7, moved a secondary amendment to similarly strike "Republican" from the title. The amendment, as amended, passed.

Thomas Warren, SD 31, moved with a second to replace "on the May 6 uniform election date" with "in the 2023 uniform election dates" in the first *Whereas* clause and to strike "in the May 6 election" from the *Resolved* clause. With a second, Jim Pikl, SD 8, moved a secondary amendment to strike all references to elections in 2023, and the secondary amendment passed. The amendment, as amended, passed. The resolution, as amended, passed by electronic roll call vote of 61 Yes, 0 No, 2 Abstain.

By direction of the Committee, Mr. Bowen moved the adoption of the "Resolution to Endorse Legislation to End Vaccine Mandates in Texas." Jim Pikl, SD 8, moved with a second to move specific references to bills from the *Resolved* clause to a *Whereas* clause, and the amendment passed. The resolution, as amended, passed by electronic roll call vote of 62 Yes, 0 No.

Scott Bowen, SD 6, moved with a second that the SREC enter into executive session. The motion passed, and the SREC entered into executive session at 10:55 a.m. The SREC proceeded in executive session until 11:58 a.m.

When the open meeting resumed, and in accordance with the terms of Republican Party of Texas Rule 44, the "Resolution Censuring Congressman Tony Gonzales by the Republican Party of Texas," as amended, passed by electronic roll call vote of 57 Yes, 5 No, 1 Abstain.

Steve Evans, SD 28, gave the report of the Rules Committee. By direction of the Committee, Mr. Evans moved that Republican Party of Texas Rule 8(f) be amended by adding language as follows:

## Rule No. 8 – Supplementary Executive Committee Rules and Meetings

f. Limitations on County Executive Committee (CEC) Meetings – No County Executive Committee meeting shall be held two (2) days prior, during, or two (2) days after the week of the biennial State Convention or during any calendar week in which committee meetings or general sessions of the quadrennial National Convention are scheduled.

Once a County Executive Committee meeting has been properly noticed in accordance with these Rules and the Rules or Bylaws of the County Executive Committee, no other County Executive Committee meeting of any type, other than for statutory business, shall be held during the period that runs from two (2) days prior to two (2) days after the scheduled County Executive Committee meeting.

Dwayne Wright, SD 5, rose to a point of order, citing the requirements under Republican Party of Texas Rule 1(c). The Chairman ruled that the point of order was not well taken.

Dwayne Wright, SD 5, moved with a second to substitute the following for the added language:

In the event multiple CEC meetings are called, the meeting called by the County Chairman shall be recognized as the official meeting.

Steve Evans, SD 28, rose to a point of order on the proposed substitute, citing conflicts with County Executive Committee Rules and Bylaws. The Chairman ruled that the point of order was not well taken. Matt Patrick, SD 16, rose to a point of order on the proposed substitute, citing the requirements under Republican Party of Texas Rule 1(c). The Chairman ruled that the point of order was well taken. The motion passed by electronic roll call vote of 51 Yes, 8 No, 4 Abstain.

By direction of the Committee, Mr. Evans moved that SREC Standing Rule III be amended to add the following language:

## III. Use of RPT Staff and Resources for Campaigns

- A. With the exception of standing rule III (B), the The staff and resources of the Republican Party of Texas may be made available to support the campaign efforts of Republican nominees in any way that is not in conflict with RPT Rules or SREC Bylaws. These resources may be made available in the same way to support the campaigns of Republican candidates in non-contested primaries and identifiable Republican candidates in non-partisan races where authorized by resolution of the SREC.
- B. The local Government Committee may, in one or more meetings called in accordance with the SREC Bylaws, report proposed endorsements of candidates who have satisfied the requirements listed in the Standing Rules of the Local Government Committee and whose answers to questions are determined by the Committee to be aligned with the Principles of the Republican Party of Texas. Any endorsements proposed by the Local Government Committee shall be sent by email to all SREC members by RPT staff. SREC members shall have five (5) calendar days after the day each proposed endorsement is sent to object to any proposed endorsements. An endorsement of any candidate shall be considered approved by the SREC after the fifth calendar day unless it is objected to by one-fourth (1/4) of the total SREC membership or it is objected to by any individual SREC member who represents a Senate District that contains territory within the jurisdiction in which the candidate is running for election. Approved endorsement shall not take effect until the endorsed candidate signs and returns the endorsement disclaimer to the Secretary of the Republican Party of Texas.

The motion passed by electronic roll call vote of 56 Yes, 0 No, 6 Abstain.

Without objection, Steve Evans, SD 28, moved that the Secretary be authorized to make spelling, grammatical, and clerical corrections to documents approved or amended by the SREC at this meeting.

At 12:53 p.m., Chairman Rinaldi announced that he was departing to attend an event. Vice Chairman Dana Myers assumed the role of presiding.

Next, Jill Glover, SD 12, gave the report of the Legislative Priorities Committee. Devvie Duke, SD 22, gave the report of the Election Integrity Committee.

The SREC then heard reports from special committees. Alma Jackson gave the report of the Engagement Committee.

Rolando Garcia, SD 15, gave the report of the Local Government Committee. By direction of the Committee, Mr. Garcia moved the adoption of the SREC Local Government Committee Standing Rules as follows:

- 1. Any candidate wishing to be endorsed must first be endorsed by at least one (1) County Executive Committee (CEC) with territory within the jurisdiction the candidate wishes to represent.
- 2. Candidates must complete the application provided by the Local Government Committee prior to an endorsement decision.

The Standing Rules were adopted by electronic roll call vote of 61 Yes, 1 No.

Gaylyn DeVine, SD 11, gave the report of the Convention Planning Committee. Matt Patrick, SD 16, gave the report of the Platform Advocacy Committee. Bruce Bishop, SD 2, gave the report of the Candidate Development Committee.

The SREC then proceeded to New Business.

Vice Chairman Myers noted that the SREC Sergeant-at-Arms Mike McCloskey had submitted his resignation effective at the adjournment of this meeting. She expressed the gratitude of the SREC for his service, and Mr. McCloskey addressed the SREC.

Without objection, the SREC entered into executive session at 1:39 p.m. The SREC proceeded in executive session until 2:27 p.m.

When the open meeting resumed, Gaylyn DeVine, SD 11, moved that the SREC adjourn, and without objection, the First Quarter 2023 SREC Meeting adjourned at 2:28 p.m. CST.
