

# Policies and Procedures for 2024 State Republican Convention Exhibitors

## **Application Process**

Exhibition or advertising space for the 2024 State Republican Convention will be granted by invitation only and at the sole discretion of the Republican Party of Texas ("RPT") and in accordance with RPT Rule No. 37. After receiving an invitation from RPT, applicants shall submit (1) a completed RPT registration form, (2) full payment, (3) an executed Exhibitor Agreement, and (4) any other documents required by RPT.

Should an individual, group, or entity who did not receive an invitation desire one, they may contact the RPT Executive Director via conventions@texasgop.org or the Exhibit Coordinator designated by RPT, Charles Langley, via exhibits@texasgop.org to request an invitation.

### **Communication with RPT**

All communication regarding exhibition space for the 2024 State Republican Convention shall be through the RPT Executive Director via conventions@texasgop.org or the Exhibit Coordinator designated by RPT, Charles Langley, via exhibits@texasgop.org.

#### **Notice**

Offensive, sexually oriented, racially biased, or lewd material is not permitted. In addition, no protesting or demonstrating will be allowed in the exhibit area.

Individuals, groups, or entities that intend to distribute literature or other information that is contrary to RPT principles may be denied space at the sole discretion of the RPT. In the event that an application is found to be in conflict with the principles of RPT, the applicant will be notified by RPT and a refund of any payment made to RPT for exhibition or advertising space by the applicant will be issued.

#### **Exhibitor Responsibility**

Each exhibitor and exhibitor's agents, employees, guests, and patrons are required to follow all rules of the Henry B. González Convention Center ("Convention Center"), Visit San Antonio, and RPT. Each exhibitor is solely responsible for any damage to the Convention Center or Visit San Antonio property caused by the exhibitor or exhibitor's agents, employees, guests, or patrons. If an exhibitor or exhibitor's agents, employees, guests, or patrons fail to follow the rules of the Convention Center and the exhibit hall, they may be required to leave at the sole discretion of RPT and no refund will be issued.

#### **Indemnity of RPT**

Each exhibitor shall indemnify and hold RPT and RPT's employees, directors, officials, representatives, and volunteers, individually and collectively, harmless from and against all actions, causes of action, claims, costs, damages, demands, expenses, fees, fines, liability, liens, penalties, proceedings, and suits of any kind and nature (including attorneys' fees) asserted against RPT or incurred by RPT, arising out of or in connection with any claim for damages to property or injuries to persons caused by the acts or omissions of each exhibitor or exhibitor's agents, employees, or guests.
