Proxy Committee Chair reported that the proxies submitted were in order. The report of the Proxy Committee was approved via voice vote.

Paul Braswell, SD-30 made a motion to adjourn no later than 11:15am. Motion was seconded and passed via voice vote.

Chairman Dickey called for the confirmation of the SREC committee appointments as presented in the call. Lisa Sprinkle, SD-29 moved to postpone indefinitely the consideration of the committee appointments. Motion was seconded.

During discussion Chairman Dickey stated that under the bylaws, the chairman had the right to create and appoint ad hoc committees at will. If the SREC does not approve the committees' membership, then the SREC will not be able to hear the reports from the ad hoc committees. Melinda Fredricks, SD-4 raised a point of order about the chairman's statement, and called his attention to Article VII, Section 9 which states that special committees, as deemed necessary, may be appointed by the Chairman , subject to the confirmation of the SREC. Chairman Dickey further explained his understanding of the chair's authority to appoint ad hoc committees. Mrs. Fredricks challenged the ruling of the chair, to which the chairman deemed the challenge out of order since the chairman had made no ruling subject to challenge.

The Chairman called for a vote on the motion to postpone indefinitely to approval of the committee appointments. Motion fails via voice vote. Motion from the floor was made and seconded for a roll call vote on the motion. Roll call motion failed via voice vote.

Jeremy Blosser, SD-10 moved to reconsider the time to adjourn at a time certain. The motion was seconded and discussed. Will Robbins, SD-4 called the question with a second. Motion to call the question passed via voice vote. Motion to reconsider passed via standing vote of 30 in favor and 23 against.

Jeremy Blosser, SD-10 with a second called the question on the motion to adjourn at 11:15am. Motion to call the question passed via voice vote. Reconsidered motion to adjourn at a time certain failed via voice vote.

Lisa Sprinkle, SD-29 moved to divide the question and consider the changes to each committee separately and the motion was seconded. After discussion, the motion failed via voice vote.

Melinda Fredricks, SD-4 raised a point of order that according to Roberts Rules of Order, any member may request the separation of items that are being voted on, and it is a non-debatable request. The Chairman replied that the motion was to divide the question and consider the changes to each committee separately as opposed to debating each change individually. The motion before the body is to consider the removals and additions to the committees.

Mark McCloskey, SD-5 made a motion that no individual be allowed to serve on more than one committee at a time. The Chairman ruled the motion out of order since it constitutes a by-law amendment.

Mark Dunham, SD-29 made a motion for a roll call vote on the motion to divide the question and the motion was seconded. Motion failed via voice vote.

Terry Holcomb, SD-3 with a second called the question on the motion to approve the committee changes as presented in the meeting call notice. Motion failed via standing vote.

Mark McCloskey, SD-5 reintroduced his earlier motion that no individual be allowed to serve on more than one committee at a time. Point of order was raised by Jeremy Blosser, SD-10 that the chair had

earlier ruled this motion was out of order since it constituted a by-law amendment. The Chairman concurred with the point of order, and the motion was ruled out of order.

Steve Atwell, SD-9 moved to add and delete names on the CRC committee. The Chairman stated that he is modifying his report to the SREC to include the changes noted.

Mike McCloskey, SD-5 moved, with a second to remove Mark Ramsey from the Rules or Resolutions committee, Karl Voigtsberger from the Resolutions Committee, and Jeremy Blosser from the Rules Committee. After discussion the motion failed via standing vote of 18 for and 36 against.

Motion to call the question was made by Randall Dunning, SD-16 with a second. Motion passed via standing vote of 48 in favor.

Motion to approve the changes to the committees (list attached) was passed via standing vote of 43 in favor and 10 against.

The Chairman appointed J. T. Edwards, SD-11 as chairman of the Auxiliaries and Coalitions Committee.

Randall Dunning, SD-16 moved, with a second to, accept the staff recommendations for changes in the schedule of committee meetings. Motion passed via voice vote.

Motion to adjourn was made by Will Robbins, SD-4 with a second by. Motion passed via voice vote

Meeting adjourned at 12:07pm.
