Special Resolution Honoring Debbie Terry. (Speakers: James Dickey, David Halvorson, Anne Gebhart, Deon Starnes, Vergel Cruz, Tim Terry) passes unanimously by voice vote.

David Covey, SD-3, offered prayer.

The meeting recessed for lunch at 12:00pm.

The meeting resumed at 1:07pm.

Vergel Cruz, SD-15, gave the report of the Resolution Committee. At the direction of the Committee, Vergel Cruz, SD-15, moved adoption of "Resolution on Financial Support for Candidates Who Support the Right-To-Life Planks". The resolution passed by an electronic roll call vote of 58 ayes to 0 nays.

At the direction of the Committee, Vergel Cruz, SD-15, moved adoption of "The Big Four". Walter West, SD-4, moved with a second to amend the resolution by replacing the "." with "!". The amendment passed by voice vote. The resolution as amended passed by an electronic roll call vote of 37 ayes to 15 nays.

At the direction of the Committee, Vergel Cruz, SD-15, moved adoption of "Resolution on Voter Roll Integrity". The resolution passed by an electronic roll call vote of 59 ayes to 0 nays.

At the direction of the Committee, Vergel Cruz, SD-15, moved adoption of "Second and Fourth Amendment Resolution against Red Flag and Enhanced Background Checks". Randall Dunning, SD-16, moved with a second to amend the resolution by replacing "further expansion" with "implementation". The amendment passed by voice vote. Britton Brooks, SD-30, moved with a second to amend the resolution by striking "in some cases, death at the hands of overzealous law enforcement". Sam Bryant, SD-22, moved with a second to amend the amendment by adding "and in some cases where the serving of a Red Flag Warrant has resulted in unnecessary deaths". The amended amendment passed by voice vote. The amendment passed by voice vote. Tanya Robertson, SD-11, moved with a second the addition of "BE IT FINALLY RESOLVED that this resolution be distributed to all Republican member of the Texas House of Representatives and Senate, the Governor, Lieutenant Governor, all Republican member representing the State of Texas in the United States House of

Representatives and Senate." The amendment passed by voice vote. The resolution as amended passed by an electronic roll call vote of 62 ayes to 0 nays.

At the direction of the Committee, Vergel Cruz, SD-15, moved adoption of "Resolution Calling for a Special Session of the Eighty-Sixth Legislature to Implement the Five Legislative Priorities of the Republican Party of Texas". Tanya Robertson, SD-11, moved with a second the addition of "BE IT FINALLY RESOLVED that this resolution be distributed to all Republican member of the Texas House of Representatives and Senate, the Governor, Lieutenant Governor." The amendment passed by voice vote. The resolution as amended passed by an electronic roll call vote of 39 ayes to 22 nays.

At the direction of the Committee, Vergel Cruz, SD-15, moved adoption of "Resolution Urging Support of the Republican Party of Texas Platform Planks Related to the Right to Keep and Bear Arms". The resolution passed by an electronic roll call vote of 62 ayes to 0 nays.

At the direction of the Committee, Vergel Cruz, SD-15, moved adoption of "Resolution on Maintaining Trust and Integrity in Our Texas House". Mark Ramsey, SD-7, moved with a second to substitute an additional "Where As the State Republican Executive Committee has significant concerns about the possibility of unbecoming behavior" for the Where As's between the first and last; and substitute "THEREFORE BE IT RESOLVED that State Republican Executive Committee demands both truth and full transparency by all parties involved and encourages a higher standard of always doing what is right instead of a lower standard of what may be legal." for the first Resolved. Chuck Branch, SD-8, moved with a second to amend the amendment by substituting the word "ethical" for the word "right". The amendment passed by voice vote. Jack Barcroft, SD-24, moved with a second to remove language that Speaker Bonnen initiated the meeting, with "between". The amendment to the amended amendment passed by voice vote. The resolution as amended passed by an electronic roll call vote of 57 ayes to 1 nay.

Justice Brett Busby, comments.

At the direction of the Committee, Mr. Cruz moved adoption of "Resolution Urging Texans to Use Caution Concerning TAPS". The resolution passed by an electronic roll call vote of 50 ayes to 1 nay.

Jan Duncan, SD-14, gave the Rules Committee report. At the direction of the Rules Committee, Jan Duncan, SD-14, add language to Rule 1 "I. In these rules a list of items in a rule excludes the items not listed, unless the rule provides otherwise or unless the context or another rule require otherwise. The phrase "including but not limited to" means that the listed items following are included as examples of what it meant without excluding other items not specifically listed." Passed with an electronic roll call vote of 54 ayes to 0 nays.

At the direction of the Rules Committee, Jan Duncan, SD-14, add language to end of Rule 8a "Any county executive committee of a county with a population of fewer than 300,000 may, by majority vote, opt out of this requirement." Passed with an electronic roll call vote of 50 ayes to 6 nays.

At the direction of the Rules Committee, Jan Duncan, SD-14, add language prior to the last sentence of Rule 34c "Legislative priorities should adhere to the "one subject" rule in the Texas Constitution governing legislation." Substitute "fifteen (15)" in place of "eight (8) in the second

sentence. Strike "eight (8)" in the third sentence. Substitute "those in the top half of those" in place of "the five (5)" in the third sentence. Passed with an electronic roll call vote of 54 ayes to 2 nays.

Mark Ramsey, SD-7, gave the report of the Legislative Priorities Committee.

Deon Starnes, SD-30, gave the report of the Convention Arrangements Committee.

Tanya Robertson, SD-11, gave the report of the Advancement Committee.

Vice Chair Alma Jackson gave the report of the Engagement Committee.

Tanya Robertson, SD-11, moved with a second to suspend the Rules to consider a resolution. Passed by voice vote.

Tanya Robertson, SD-11, moved with a second to adopt the "Resolution in Support of Proposition 4". Passed with an electronic roll call vote of 52 ayes to 0 nays.

Michael McCloskey, SD-5, moved with a second to adjourn. The motion passed by voice vote.
