James Dickey, Chairman, gave the Officials Committee report. Presented the 2020 Budget for approval. MOTION to add \$100,000 for county website expenses, made by Marian Knowlton, SD-19, and seconded was approved by voice vote. The amended budget was approved without objection.

James Dickey, Chairman, appointed David Luther, SD-18, to Rules and Convention Arrangements without objection the appointments were approved.

Steve Atwell, SD-9, gave the Candidate Resource Committee report.

David Halvorson, SD-12, gave the report of the Resolution Committee. At the direction of the Committee, David Halvorson, SD-12, moved adoption of "Resolution on Sex Treatment of Minor Children". The resolution passed by an electronic roll call vote of 52 ayes to 2 nays.

At the direction of the Committee, David Halvorson, SD-12, moved adoption of "Resolution Supporting our President". Mark Ramsey, SD-7, moved with a second to amend by adding language to distribute to the other state parties in the RNC. The amendment passed by voice vote without decent. The resolution passed unanimously by an electronic roll call vote of 60 ayes to 0 nays.

At the direction of the Committee, David Halvorson, SD-12, moved adoption of "Resolution for Protection of the Alamo". Michael Raign, SD-26, moved with second to add the word "Cenotaph". The motion passed by voice vote. Anne Gebhart, SD-9, moved with second to include the Daughters of the Republic of Texas in the distribution list. Amendment passed by voice vote. The resolution as amended passed by an electronic roll call vote of 49 ayes to 8 nays.

At the direction of the Committee, David Halvorson, SD-12, moved adoption of 10 Ballot Propositions. Chris McDonald, SD-6, moved with second to strike the Qualitied Immunity proposition, motion approved by voice vote. Britton Brooks, SD-30, motion with second to add term limits of 14 years for state representatives and 16 years for state senators. JT Edwards, SD-11, motion with second to amend the amendment to agree with the 2018 RPT platform of 12 years for each. Amendment passed by voice vote. Motion to add the term limits proposition passed by electronic vote of 29-26. Tripp Bryant, SD-22, motion with a second to strike the word "abortion" from the Parental Rights proposition. Motion passed by standing vote. Adoption of the 10 Ballot Propositions as amended passed by electronic vote of 49 ayes to 7 nays.

Gale Stanart, SD-15, gave the Rules Committee report. At the direction of the Committee, Gale Stanart, SD-15, moved the change to Art VII, Section 8, A, 5, c. Mark Ramsey, SD-7, moved with

second to change the amount from \$2,000 to \$5,000 for 1099 contractors and consultants. Motion passed by standing vote. Adopted the Rules change with a record vote of 41 ayes to 10 nays.

James Dickey, Chairman, announce the resignation of Kathaleen Wall, SD-17, from the Election Integrity Working Group chair and appointed Dawn Elliott, SD-13, as a replacement member and chair for the working group.

Mark Ramsey, SD-7, gave the report of the Legislative Priorities Committee. At the direction of the Committee, Mark Ramsey, SD-7, motion to request candidate positions on the current RPT legislative priorities and publish. Motion passed by voice vote.

Deon Starnes, SD-30, gave the report of the Convention Arrangements Committee. At the direction of the Committee, Deon Starnes, SD-30, moved to set the convening time for the RPT State Convention on 14 May 2020 at 9:00AM. Motion passed by voice vote. At the direction of the Committee, Deon Starnes, SD-30, moved to adopt Derek Ryan's delegation allotment. Motion passed by voice vote.

Tanya Robertson, SD-11, gave the report of the Advancement Committee.

Vice Chair Alma Jackson gave the report of the Engagement Committee.

James Dickey, Chairman, appointed Jill Glover, SD-12, to the Auxiliaries & Coalitions Committee. Appointment was accepted by voice vote.
